

The meaning behind the Andersen Doors

The origin of our iconic symbol is closely woven with a story that illustrates how deeply real estate is connected with Andersen:

In the last century, when Arthur Andersen & Co. had significantly grown, the firm needed a new space. The company ended up leasing the top floor of a Chicago building. It's said that Arthur Andersen himself cut the deal for this location – leasing it for just \$1 per square foot.

At that time Vilas Johnson was the Chicago office manager and Andersen delegated matters of décor for the newly rented space to him. Johnson was the man behind Andersen's training program and had relationships with the deans and department heads

of the most important colleges and universities. Johnson's passion for campuses might have come from his alma mater, Oxford. This is also where he drew the inspiration for his new task, giving the new office space of Arthur Andersen & Co. a distinct look.

It is said that Vilas Johnson himself created the design of the Arthur Andersen doors after some he had seen in England. The only difference being that his design, with three indented panels on each door, allowed the placing of the firm's name across both of them.

At the time, wooden doors seemed like an odd choice for a firm – glass doors were en vogue. And it was common practice for accounting firms to list all their office locations next to the company's name. A thought that Johnson strictly rejected – with an iconic quote that perfectly sums up our self-conception:

"These are not billboards. These are the doors to a firm of professionals."
